## DIRECTIONS FOR USE - PALMS

(For best results make both Soil and Foliar applications) Foliar Application: Mix this material at the rate of 1-2 tablespoonfuls per gallon of water (1.5-3 quarts per 100 gallons). Apply to thoroughly wet the fronds to the point of runoff, also spray some of the material directly into the heart of the palm. (Other Ornamentals: use at the same rate and spray to the point of runoff.)

Soil Application: For small palms use 1 oz. of material in at least one half gallon of water per tree.

For medium sized palms use 2-4 oz. of material in at least one gallon of water per tree. For large palms use 4-8 fluid ounces in at least 2 gallons of water per tree. Treat the root area, this area usually extends out as far as the foliage. Curative applications: apply every 14 days until cured

Preventative maintenance: apply every 3-4 months. <u>NOTE:</u> Deficiency symptoms in many plants are an indication of improper pH. Soil pH should be checked and adjusted if necessary.
